Legal Services of Northwest Jersey (LSNWJ) is a private non-profit law firm that provides free legal services to people with limited income and vulnerable seniors of Hunterdon, Morris, Somerset, Sussex, and Warren Counties.

Qualification:

When you contact LSNWJ, you will be screened for eligibility. LSNWJ's Senior Legal Assistance Project serves seniors, age 60 or older, who do not have the resources to obtain private counsel. If you qualify for services and your issue falls within LSNWJ's priorities, an appointment will be made for you to speak with an attorney. For applicants under age 60, the following income guidelines apply.
